



RESOLUTION NUMBER 2024-6-2

A RESOLUTION PURSUANT TO CHAPTER 72 OF THE CITY CODE OF THE CITY OF STACY ADOPTING NO PARKING ZONES WITHIN THE CITY

WHEREAS, the City Council for the City of Stacy has adopted no parking restrictions within the City on CSAH 30 and County Road 19 near the intersection of the same two roads; and in areas of the Stacy Ponds Business Park; and

WHEREAS, the City wishes to codify all parking restrictions in one location.

NOW, THEREFORE, based on the foregoing, the City Council for the City of Stacy hereby adopts the following:

1. Parking of all motor vehicles, and all other non-motorized vehicles, is hereby prohibited at all times, as follows:
 - a. No parking along the western portion of CSAH 30 north from the intersection of CSAH 30 and County Road 19 a distance of 285 feet, as designated.
 - b. No parking along the eastern portion of CSAH 30 north from the intersection of CSAH 30 and County Road 19 a distance of 300 feet, as designated.
 - c. No parking along the northerly portion of County Road 19 east from the intersection of County Road 19 and CSAH 30 a distance of 335 feet, as designated.
 - d. No parking along the southerly portion of County Road 19 east from the intersection of County Road 19 and CSAH 30 a distance of 390 feet, as designated.
 - e. No parking along the easterly portion of CSAH 30 south from the intersection of CSAH 30 and County Road 19 a distance of 850 feet, as designated.
 - f. No parking along the westerly portion of CSAH 30 south from the intersection of CSAH 30 and County Road 19 a distance of 850 feet, as designated.
 - g. No parking along the southerly portion of County Road 19 west from the intersection of County Road 19 and CSAH 30 a distance of 425 feet, as designated.
 - h. No parking along the northerly portion of County Road 19 west from the intersection of County Road 19 and CSAH 30 a distance of 400 feet, as designated.
2. No Parking:
 - a. North Side of Stacy Trail from Interstate 35 to west property line of 5660 Stacy Trail



- b. South Side of Stacy Trail from Interstate 35 to east property line of 5675 Stacy Trail.
 - c. North Side of Stacy Trail from Foster Avenue to east Property line of 5860 Stacy Trail
 - d. South side of Stacy Trail from east property line of 5805 Stacy Trail to west property line of 5891 Stacy Trail
 - e. North side of Stacy Trail from east property line of 6000 Stacy Trail to Forest Boulevard (CSAH 30)
 - f. South side of Stacy Trail from east property line of 5975 Stacy Trail to Forest Boulevard (CSAH 30)
3. The City Council of Stacy hereby declares the property located in front of 6115 Stacy Trail is a no parking area and shall be designated so immediately and marketed thereto.
 4. The City Council declares that both sides of the northern most cul-de-sac in the Stacy Ponds Business Park within 100 Feet on either side of the cul-de-sac and within the cul-de-sac.
 5. The City Council declares both sides of the southern most cul-de-sac in the Stacy Ponds Business Park within 100 Feet on either side of the cul-de-sac and within the cul-de-sac.
 6. The City Council declares both sides of Sherman Oaks Road West of Ferris Trail as a no parking zone on both the North and South Sides of the road.
 7. The City Council declares Stacy Ponds Drive as a no parking zone within 716 feet from the intersection of County Road 30 on both the North and South sides of the road.
 8. The City Council declares Falcon Avenue South as a no parking zone within 530 feet from the intersection of Stacy Trail on both the East and West sides of the road.
