LIGHT INDUSTRIAL DISTRICT PERMITTED USES, SECTION 153.051
GENERAL BUSINESS PERMITTED USES

The City Council of Stacy ordains:

SECTION 1. Section 112.03 of the Stacy City Code is amended to establish the following definitions:

TAPROOM. Location where on-sale malt liquor produced by a brewer is available for consumption on the premises of or adjacent to one brewery location owned by the brewer.

MICRO DISTILLERY. A distillery located within the city producing premium distilled spirits in total quantity not to exceed 40,000 proof gallons per calendar year.

BREWERY. A location where malt liquor is produced.
by amending the definition of “restaurant” to read as follows:

Amend City Code §153.053 (B) Permitted Uses; add item (5):

(5) Micro Distillery or Brewery.

Amend City Code §153.051 B Permitted Uses; add item (15):

(15) Taprooms.

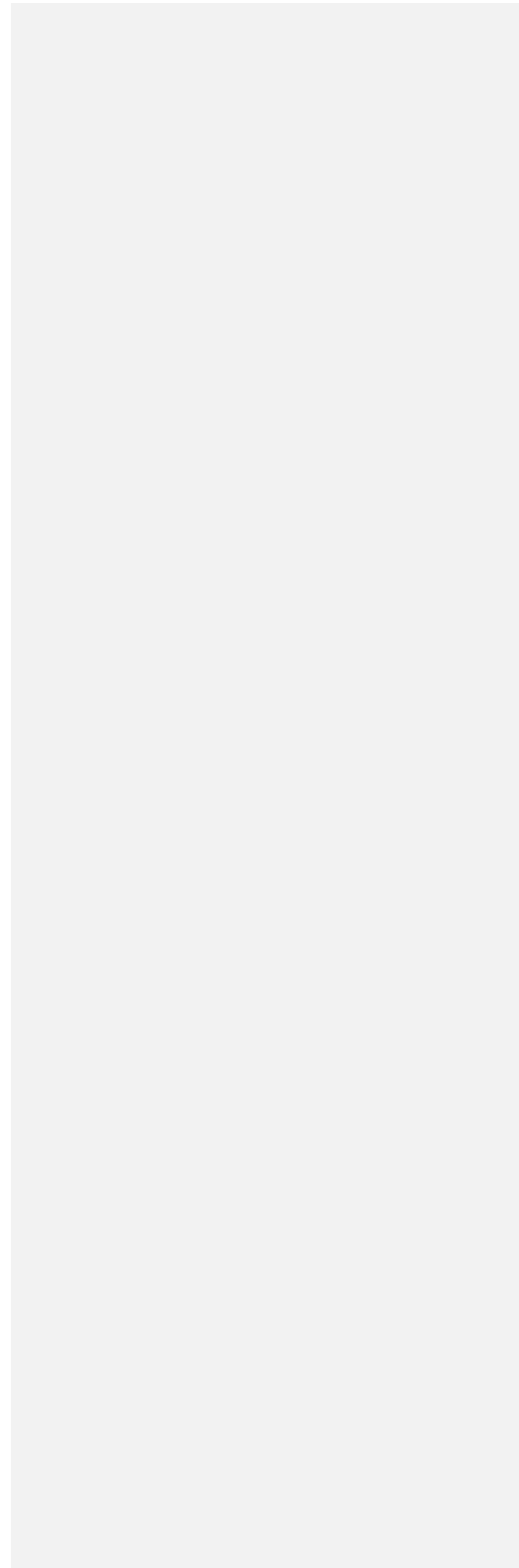
Commented [JM1]: This language should be removed or if the definition of restaurant is being amended than additional language should be added.

Commented [JM2]: This makes taprooms a permitted use in the General Business District. But, a taproom must be on the premises of or adjacent to a brewery. Minn. Stat. § 340A.26 subd. 1. A brewery is not a permitted use in the General Business District, so a taproom could not exist in that zone. A “brew pub” does not need to be attached to a brewery. Minn. Stat. 340A.24 Beer is brewed on premises at a “brew pub”.
