Discussion

Due to COVID exposure at the Sports Grill the manager is seeking direction on closing the sports grill temporarily. The council and Manager Wicklander made the following points:

- Ability to Staff
- The extent of the exposure is not known
- The ability to manage the Sports Grill
- Staff would like to return to work
- The city cannot require COVID testing
- Close for 10 days and at least 72 hours of no symptoms (part of the 10 days).
- Close for 14 days considered.
