Good morning Aerica,

It was a pleasure to speak with you yesterday. Attached please find our updated Agreement for 2022. Per our discussion, the current rate will be in effect until December 31, 2021. Hopefully the attached new Agreement rate will be approved by the end of the year to be effective January 1st, 2022. I have also attached a letter that went out to all of our business partners in 2020 about a mandate regarding special min. wages. If you could share this with the council meeting coming up, we would appreciate it.

Please note: Due to a special minimum wage mandate, Rise will need to begin billing the MN minimum hourly wage, plus a mark-up of 25% per person per hour beginning January 2023. (See attached letter sent to Rise business partners in 2020).

We wanted to give a year advance notice to those business partners (like Stacy) that we currently use special min. wages for billing.

We value our partnership with Stacy Sports Grill very much and appreciate the work opportunities for the people we serve. Please let me know if you have further questions.
