RE: April 2019 Liquor Operations Financial Statements

Please find attached the April 2019 financial statements.

It is with great pleasure to show that we had another excellent month from both the Wine and Spirits and the Bar and Grill. Both locations turned a profit even after the bond payment for the Bar and Grill! Total consolidated net income was \$32,305.98. Year to date net loss is \$120799.35. Again, this is only due to the fact that the Wine and Spirits Bond was paid off in January for \$170,000.00. Without the bond payoff, the net profit would be \$49,200.65.

Items highlighted in PURPLE on the P&L's are areas I am noting. Please note, per the request of the council, the bond payments were moved into the normal net income/loss section. The bond payments are a true cost of doing business and should be noted here for realistic numbers.

On Sale – Net income of \$9,247.53. Revenue was just under \$63,000 for the month. Down about \$13,000 from the previous month. Sales are about the same (under \$1,000 difference) as April 2018. The difference is that expenses are much lower this year resulting in a profit rather than a net loss for April. Items to note include the inventory COGS. It was noted last month that Johnny was overhauling the inventory for the bar. This was completed and resulted in many adjustments on the financials. This will even back out next month and going forward since it is now corrected. There was also a conference that was attended by Johnny as well as the liquor store managers in April. This is reflected in the training and travel expense categories. Finally, there was a refund to the liquor division for 2016 & 2017 audit expenses that were incurred. The total refund was \$5,766.66 and was split between the bar and the liquor store.

Off Sale – Net income of \$23,058.45. Revenue was just under \$203,000 for the month. Sales are up just over \$44,000 from 2018 year to date. There was a refund to the liquor division for 2016 & 2017 audit expenses that were incurred. The total refund was \$5,766.66 and was split between the bar and the liquor store. Rod and Christian also attended the conference with Johnny in April. These expenses are reflected in their training and travel expenses.
