RE: February 2015 Liquor Operations Financial Statements

Please find attached the February 2015 financial statements.

Total consolidated net income was \$8,766.86. Year to date income is \$20,550.30.

On Sale – Net income of \$2,258.19. Revenue was just above \$67,000 for the month. Liquor/Misc COGS seemed to correct itself this month as I thought it should. The costs should reflect higher in February as January's costs were low.

Off Sale – Net income of \$6,508.67. Revenue was just above \$134,000 for the month. COGS is slightly lower than normal to correct from the January higher costs. Although, I would have expected to see a bit more of a reduction.
